go over on holidays, have ready for AGM for beginning of next year. Happy to accept token voucher of \$50 per year, for 3 years total including this year. \$150 total. Maxine motions that we spend the money, Alex seconds.
Ros on long service leave - she is signatory on P\&C bank account, we need two signatories on any payment and with her not here this leaves us unable to spend money and pay people. Suggest having 2 out of 4 people, perhaps treasurer, perhaps principal as additional signatories. Janine, manager of corporate services, is the other signatory at the moment. While we're at it, might as well investigate option of EFT banking. The treasurer would implement transactions, secondary person/signatory would receive notice and put in their confirmation code for payments to proceed. Advantage of this is even if one signatory is away they can still log on online to do that. Melissa Ozich put forward motion for Anthony and Rose (Chia-Ye), Alex seconds.
Anthony motions that treasurer (Rose, Chia-Ye) is the second signatory every year. 3 other people would be school staff as signatories. Alex seconds.
Motion that we engage internet banking services with Commbank - Melissa O motioned, Shelly seconds.
Janine is happy to be 2 nd signatory for EFT services.

President nominations - none received. Still able to continue running without a president and we will notify the wider school community in the bulletin send out prior to holidays.
Anthony motions that DPC P\&C continues without president for the rest of the year, Maxine seconds.

Colour Run - books will be distributed first day of new term, we will have to section books off that first day of school. Event will run from 1:30pm onwards. Obstacle course will be set up. Melissa 0 motions that we purchase ice poles for post colour run. 1 per student, Maxine seconds. Advertise for bring a plate / picnic after the event.

Call out for volunteers for powder stations.

Disco Thursday 12th November - historically has been Halloween disco. This year could be any theme, or no theme, totally up to P\&C. Discussion about seasons, spring? Summer - beach theme? If beach then Anthony would have discussions with year 5 and 6 classes about no swimwear. Cailey suggests Hawaiian theme.
Wish kids sell tickets, run games at junior disco. P\&C does food and drinks. \$10 ticket covers sausage sizzle, juice box. 5-6:30pm for juniors then 7-8:30 for rest of school.
Melissa Ozich motions that we set the entry price of $\$ 10$ which will provide drink and sausage sizzle, implement the tick box on the permission slip. Alex seconds.
Cailey suggests tickbox "are you willing to help on the night, which session, add phone number" on permission slip.
Sana talks about renaming the event for cultural reasons, that muslim families may be reluctant as its possible it may be perceived "disco" to have adult connotations. Suggestion DPC "Beach Dance Party". Further discussion warranted.
